This Statement of Work (SOW) defines the efforts required for the production of Sonar Dome Rubber Windows, Type 1 (SDRW-1) Bead Seat Assemblies. This SOW specifically addresses:

- a. Production Planning;
- b. Quality Assurance;
- c. Facilities and Associated Efforts;
- d. Material Management;
- e. Fabrication and Assembly;
- f. Evaluation and Inspection;
- g. Production Engineering Changes and Associated Processes
- h. Program Management

1.1 **Background.** Bead Seat Castings (6667625) are steel casting designed for attachment of SDRW-1 to antisubmarine warfare surface ship hulls. The Bead Seat Assembly (6667627) consists of twenty-six castings, three types of mating Bead Clamps (6667641), and fasteners. Government furnished wood pattern are used to form the complex shape and curvature of the castings and clamps. The rough castings are machined to dimensional tolerance, holes are added, and surfaces finished. The finished castings are inspected with government furnished inspection box templates.

2.0 APPLICABLE DOCUMENTS

The following documents are applicable to this SOW to the extent specified herein. Only basic documents are referenced within this SOW. In case of conflict between this SOW and the applicable documents, the order of precedence shall be this SOW and then the applicable documents.

3.0 REQUIREMENTS**3.1 PRODUCTION PLANNING**

Production planning shall include those Contractor efforts, utilizing the Contractor's corporate processes, which are necessary for delivery of quality bead seat assemblies by all required delivery dates. These planning efforts and processes shall include integration of bead seat assemblies into the Contractor's existing or new quality assurance processes, material procurement strategies, and facilities.

3.2 QUALITY ASSURANCE (QA) PROGRAM

The Contractor shall maintain a quality system that, as a minimum, adheres to the requirements of ANSI/ASQC Q9001-1994, and the requirements of this SOW.

3.2.1 Subcontractors. The quality assurance requirements shall apply equally to the Contractor's subcontractors. The Contractor shall be responsible for qualifying and monitoring subcontractor sources in conjunction with the quality assurance requirements and material procurement.

3.3 FACILITIES AND ASSOCIATED EFFORTS

The Contractor shall develop, operate, manage, and maintain the production, fabrication, assembly and inspection facilities required for the production of bead seat assemblies, and provisions of this SOW.

3.4 FABRICATION AND ASSEMBLY

The Contractor shall fabricate and assemble in accordance with the bead seat assemblies' Technical Data Package (TDP), and this SOW. The TDP is defined by the drawings listed below and all subsequently reference documents. The top drawing for the bead seat assemblies is 53711-6667625 revision A, dated 12 January 2004. Fabrication and assembly shall be in accordance with the quality provisions in paragraph 3.2 and the Contractor's quality assurance plan. The Contractor shall report fabrication status per paragraph 5.2.1.

3.5 EVALUATION AND INSPECTION

The Contractor shall establish, document, and perform production evaluation and inspection in accordance with the requirements of the TDP and with the provisions stated in this SOW. The Contractor shall perform, as a minimum, incoming inspections, and production inspection tests to the product requirements specified by the TDP. The Contractor shall document the results, including failures, of all inspections.

4.0 PRODUCTION ENGINEERING CHANGES AND ASSOCIATED PROCESSES

4.1 CONFIGURATION CHANGE CONTROL

4.1.1 Engineering Changes. If the Contractor requires a change to the bead seat assembly product baseline, the Contractor shall submit an Engineering Change Proposals (ECP). To support and document any ECP proposed changes, a Notice of Revision shall be prepared for each document affected. [*ELINs A001, Engineering Change Proposal; A002, Notice of Revision*]

4.1.2 Deviations. The Contractor shall submit a request for deviation for items that incorporate a known departure from requirements. The Contractor shall receive Government approval prior to procurement or manufacturing of those items. This also applies to any commercial off the shelf items the Contractor procures for delivery to the Government as a part of this contract. [*ELINs A003, Request for Deviations.*]

5.0 PROGRAM MANAGEMENT

5.1 PROGRAM MANAGER

The Contractor shall designate a Program Manager (PM) who shall have responsibility for all aspects of this contract and the authority to commit the Contractor to specific courses of action. The PM shall coordinate all reviews and meetings between Navy organizations and the Contractor including ensuring the attendance of key Contractor personnel.

5.2 COST/SCHEDULE MANAGEMENT

5.2.1 Progress, Status, and Management. The Contractor shall develop and maintain a Contractor's Progress, Status, and Management Report, which clearly present the Contractor's schedule planning as well as related Government responsibilities, and interactions for the efforts required for development and production of bead seat assemblies. [*ELIN A004 Contractor's Progress, Status, and Management Report.*]

6.0 STORAGE AND SHIPPING

6.1. Protect and Package. The Contractor shall protect and package Bead Seat Castings in accordance drawing 53711-6667627. Bead Clamps shall be protected and packaged per drawing 53711-6667625.

6.2 Storage and Shipping Requirements. Following acceptance of the Bead Seat Castings and associated supplies at source by the Government, the Contractor shall store these items for a period not-to-exceed 90 days. Shipping Instructions will be supplied by NSWC Crane Division point of contact, DeWayne Sims (812) 854-2270, within the 90-day storage period. The contractor shall then deliver the items listed on the shipping instructions to the destination(s) specified therein within 15 days after notification of shipping instructions. CLAUSES IN FULL TEXT

ORDERING (OCT 1995) (FAR 52.216-18)

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from _____ through five years from the effective date of contract.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

INDEFINITE QUANTITY (OCT 1995) (FAR 52.216-22)

(a) This is an indefinite-quantity contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies and services specified in the Schedule are estimates only and are not purchased by this contract.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. The Contractor shall furnish to the Government, when and if ordered, the supplies or services specified in the Schedule up to and including the quantity designated in the Schedule as the "maximum". The Government shall order at least the quantity of supplies or services designated in the Schedule as the "minimum."

(c) Except for any limitations on quantities in the Order Limitations clause or in the Schedule, there is no limit on the number of orders that may be issued. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(d) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after 66 months from the effective date of contract.

(a) *Definitions.* As used in this clause--

"Commercial item" has the meaning contained in the clause at 52.202-1, Definitions.

"Subcontract" includes a transfer of commercial items between divisions, subsidiaries, or affiliates of the Contractor or subcontractor at any tier.

(b) To the maximum extent practicable, the Contractor shall incorporate, and require its subcontractors at all tiers to incorporate, commercial items or nondevelopmental items as components of items to be supplied under this contract.

(c)

 - (iv) 52.222-36, Affirmative Action for Workers with Disabilities (Jun 1998) (29 U.S.C. 793).
 - (v) 52.247-64, Preference for Privately Owned U.S.-Flag Commercial Vessels (Apr 2003) (46 U.S.C. Appx 1241 and 10 U.S.C. 2631) (flow down required in accordance with paragraph (d) of FAR clause 52.247-64).
- (2) While not required, the Contractor may flow down to subcontracts for commercial items a minimal number of additional clauses necessary to satisfy its contractual obligations.
- (d) The Contractor shall include the terms of this clause, including this paragraph (d), in subcontracts awarded under this contract.

GOVERNMENT PROPERTY (FIXED-PRICE CONTRACTS) (JUN 2003) (FAR 52.245-2)

(a) Government-furnished property.

(1) The Government shall deliver to the Contractor, for use in connection with and under the terms of this contract, the Government-furnished property described in the Schedule or specifications together with any related data and information that the Contractor may request and is reasonably required for the intended use of the property (hereinafter referred to as "Government-furnished property").

(2) The delivery or performance dates for this contract are based upon the expectation that Government-furnished property suitable for use (except for property furnished "as is") will be delivered to the Contractor at the times stated in the Schedule or, if not so stated, in sufficient time to enable the Contractor to meet the contract's delivery or performance dates.

(3) If Government-furnished property is received by the Contractor in a condition not suitable for the intended use, the Contractor shall, upon receipt of it, notify the Contracting Officer, detailing the facts, and, as directed by the Contracting Officer and at Government expense, either repair, modify, return, or otherwise dispose of the property. After completing the directed action and upon written request of the Contractor, the Contracting Officer shall make an equitable adjustment as provided in paragraph (h) of this clause.

(4) If Government-furnished property is not delivered to the Contractor by the required time, the Contracting Officer shall, upon the Contractor's timely written request, make a determination of the delay, if any, caused the Contractor and shall make an equitable adjustment in accordance with paragraph (h) of this clause.

(b) Changes in Government-furnished property.

(1) The Contracting Officer may, by written notice, (i) decrease the Government-furnished property provided or to be provided under this contract, or (ii) substitute other Government-furnished property for the property to be provided by the Government, or to be acquired by the Contractor for the Government, under this contract. The Contractor shall promptly take such action as the Contracting Officer may direct regarding the removal, shipment, or disposal of the property covered by such notice.

(2) Upon the Contractor's written request, the Contracting Officer shall make an equitable adjustment to the contract in accordance with paragraph (h) of this clause, if the Government has agreed in the Schedule to make the property available for performing this contract and there is any--

- (i) Decrease or substitution in this property pursuant to subparagraph (b)(1) above; or
- (ii) Withdrawal of authority to use this property, if provided under any other contract or lease.

(c) Title in Government property.

(1) The Government shall retain title to all Government-furnished property.

(2) All Government-furnished property and all property acquired by the Contractor, title to which vests in the Government under this paragraph (collectively referred to as "Government property"), are subject to the provisions of this clause. However, special tooling accountable to this contract is subject to the provisions of the Special Tooling clause and is not subject to the provisions of this clause. Title to Government property shall not be affected by its incorporation into or attachment to any property not owned by the Government, nor shall Government property become a fixture or lose its identity as personal property by being attached to any real property.

(3) Title to each item of facilities and special test equipment acquired by the Contractor for the Government under this contract shall pass to and vest in the Government when its use in performing this contract commences or when the Government has paid for it, whichever is earlier, whether or not title previously vested in the Government.

(4) If this contract contains a provision directing the Contractor to purchase material for which the Government will

reimburse the Contractor as a direct item of cost under this contract--

(i) Title to material purchased from a vendor shall pass to and vest in the Government upon the vendor's delivery of such material; and

(ii) Title to all other material shall pass to and vest in the Government upon--

(A) Issuance of the material for use in contract performance;

(B) Commencement of processing of the material or its use in contract performance; or

(C) Reimbursement of the cost of the material by the Government, whichever occurs first.

(d) Use of Government property. The Government property shall be used only for performing this contract, unless otherwise provided in this contract or approved by the Contracting Officer.

(d) Property administration.

(1) The Contractor shall be responsible and accountable for all Government property provided under this contract and shall comply with Federal Acquisition Regulation (FAR) Subpart 45.5, as in effect on the date of this contract.

(2) The Contractor shall establish and maintain a program for the use, maintenance, repair, protection, and preservation of Government property in accordance with sound industrial practice and the applicable provisions of Subpart 45.5 of the FAR.

(3) If damage occurs to Government property, the risk of which has been assumed by the Government under this contract, the Government shall replace the items or the Contractor shall make such repairs as the Government directs. However, if the Contractor cannot effect such repairs within the time required, the Contractor shall dispose of the property as directed by the Contracting Officer. When any property for which the Government is responsible is replaced or repaired, the Contracting Officer shall make an equitable adjustment in accordance with paragraph (h) of this clause.

(4) The Contractor represents that the contract price does not include any amount for repairs or replacement for which the Government is responsible. Repair or replacement of property for which the Contractor is responsible shall be accomplished by the Contractor at its own expense.

(f) Access. The Government and all its designees shall have access at all reasonable times to the premises in which any Government property is located for the purpose of inspecting the Government property.

(g) Risk of loss. Unless otherwise provided in this contract, the Contractor assumes the risk of, and shall be responsible for, any loss or destruction of, or damage to, Government property upon its delivery to the Contractor or upon passage of title to the Government under paragraph (c) of this clause. However, the Contractor is not responsible for reasonable wear and tear to Government property or for Government property properly consumed in performing this contract.

(h) Equitable adjustment. When this clause specifies an equitable adjustment, it shall be made to any affected contract provision in accordance with the procedures of the Changes clause. When appropriate, the Contracting Officer may initiate an equitable adjustment in favor of the Government. The right to an equitable adjustment shall be the Contractor's exclusive remedy. The Government shall not be liable to suit for breach of contract for--

(1) Any delay in delivery of Government-furnished property;

(2) Delivery of Government-furnished property in a condition not suitable for its intended use;

(3) A decrease in or substitution of Government-furnished property; or

(4) Failure to repair or replace Government property for which the Government is responsible.

(i) Final accounting and disposition of Government property. - (v) Holding fifty percent or more of the indebtedness of a firm.

(b) Prohibition on award.

In accordance with 10 U.S.C. 2327, no contract may be awarded to a firm or a subsidiary of a firm if the government of a terrorist country has a significant interest in the firm or subsidiary, unless a waiver is granted by the Secretary of Defense.

(c) Disclosure.

If the government of a terrorist country has a significant interest in the Offeror or a subsidiary of the Offeror, the Offeror shall disclose such interest in an attachment to its offer. If the Offeror is a subsidiary, it shall also disclose any significant interest the government of a terrorist country has in any firm that owns or controls the subsidiary.
